Council, board view middle school plan

The Common Council and Oshkosh Area School District Board of Education received a virtual tour of the proposed new middle school on New York Avenue in their joint meeting Thursday.

Nate Considine and Maria Welch of Bray Architects provided the walkthrough of the proposed design of the school, noting its masonry detail derived from its soon-to-be predecessor, Merrill School.

Salvation Army expansion to break ground

The Salvation Army of Oshkosh is marking its expansion and renovation project at 417 Algoma Blvd. with a groundbreaking ceremony at 1 p.m. June 3 with the help of its project partners Bray Architects and Miron Construction.

One primary focus is providing food to the community through a meal program and food pantry. The addition will double its existing space in those areas with an updated cafeteria, serving area, and food and retail pantry.

After a site search the organization ac-

quired property adjacent to its existing building, which will remain partially operational during construction while many programs are shifted to a rented space at the former Bella Academy for Cosmetology, 338 Pearl Ave.

Deputy Superintendent David Gundlach also gave notice to the joint workshop participants about providing widespread broadband access to students and resi-

dents of Oshkosh.

Through a recent survey, the district found that about 5 percent of its 10,000 students do not have direct access to broadband in their households. Gundlach noted the numbers were found to be accurate when COVID-19 hit and the schools provided about 500 Wi-Fi hotspots to students for their virtual learning.

He also said there may be incoming federal funds to help with this after a recent announcement by Gov. Tony Evers stating \$100 million will be granted for broadband expansion throughout the state.

Bus chair access system reviewed

The Transit Advisory Board got an update about incoming Quantum wheelchair securement systems on GO Transit buses throughout the city of Oshkosh.

A prototype was installed on one of the buses May 6. Steve Tomasic of GO Transit said the process is done by two people: Once riders center themselves on the platform, they press a button to be lifted in.

From there, the bus driver presses a button to secure and release the rider at the

beginning and end of the ride.

Tomasic said they hope to receive 11 more wheelchair securement systems for the rest of the buses by the end of this year.

City Manager Mark Rohloff said at Common Council's May 25 meeting that the wheelchair securement system additions to the remaining buses will cost about \$164,000 of the city's Coronavirus Aid, Relief and Economic Security (CARES) Act funding.

Related to transit services, EAA's AirVenture is expected to see larger numbers

than its record 2019 attendance. More than 600,000 people are expected to come in 2021 after experiencing a 40 percent increase in ticket presales.

With this, Tomasic said shuttles to and from the EAA grounds may have to increase the number of trips to follow Federal Transit Administration guidelines.

He said the shuttles will not accommodate standing riders to enforce proper distancing, and masks will still be required unless that policy changes before the weeklong event July 26 through Aug. 1.

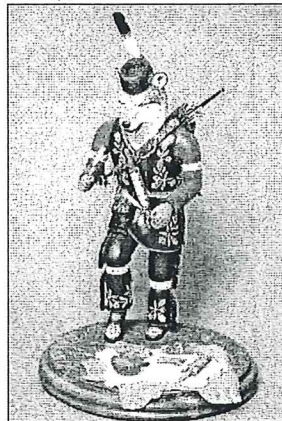
Museum to host powwow

In honor of the Menominee Clans Story exhibit opening at the Oshkosh Public Museum, Menominee Nation tribal members are presenting a powwow event from noon to 5 p.m. Saturday on the museum grounds.

The powwow's grand entry is set for 1 p.m., and visitors are encouraged to bring a chair or blanket. There will be Native American artists and food vendors.

The powwow's arena director will be Gary Besaw and master of ceremonies is Bruce Wilber. Drums will be led by Smokey Town and Wolf River Singers. Male head dancer is Ronnie Bowman and female head dancer is Dawn Wilber.

Carved and painted by the late Menominee artist James E. Frechette Jr., the Little Menominee wood figures on exhibit stand between 12 and 20 inches high carved from Menominee white pine and decorated in acrylic. They represent the stories, legends and ancient lore of the tribe. He observed the craft life of the elders and acquired principles and techniques from them.
