NOTICE IS HEREBY GIVEN that electronic bids will be received up to 11:00 a.m., Monday, December 4, 2023, through the online bidding service of QuestCDN.com, [www.QuestCDN.com](http://www.QuestCDN.com), for the construction of concrete paving, utilities, and appurtenant work. Bids will be opened and publicly read through a Zoom virtual meeting.

### CITY CONTRACT 24-15 – WEST 5<sup>TH</sup> AVENUE, WEST 7<sup>TH</sup> AVENUE, IOWA STREET, AND MICHIGAN STREET RECONSTRUCTION

Approx. 10,500 sq. yds. of 7" concrete pavement with curb and appurtenant work

Approx. 35,300 sq. ft. of 4" to 6" concrete sidewalk and driveway

Approx. 460 sq. yds. of 4" asphaltic surface and transition

Approx. 3,300 lin. ft. of 10" to 12' x 6' box culvert storm sewer and appurtenant work

Approx. 1,600 lin. ft. of 6" and 8" storm laterals

Approx. 1,300 lin. ft. of 8" to 15" sanitary sewer relay

Approx. 1,600 lin. ft. of 4" to 6" sanitary laterals (relay/new)

Approx. 200 lin. ft. of 4" to 6" sanitary lateral riser (relay)

Approx. 1,600 lin. ft. of 1" water service (relay/new)

Approx. 3,000 lin. ft. of 4" to 12" water main relay and appurtenant work

Contractors must be qualified to submit a bid for this Project. This shall be done on forms furnished by the City of Oshkosh, and must be filled out in proper manner and then submitted to the Department of Public Works for consideration by the Director of Public Works and the City Manager and filed not later than **Thursday, November 23, 2023**. **Contractors will not be allowed to bid on this City Contract if complete answers to any Department of Public Works' questions or any missing documentation has not been received by the Department of Public**

**Works by Wednesday, November 29, 2023.** The City Manager's decision as to qualifications will be final. Contractors that are prequalified with the City of Oshkosh for the construction year 2024 for the class of work **and the Total Contract Amount** specified in the *Proposal* do not need to prequalify again for this Project.

The cost of the current edition of the *Standard Specifications for the City of Oshkosh, Wisconsin* will be \$25 (Twenty Five Dollars) and will be available at the City Engineer's office.

Sealed Bids must be accompanied by a Bid Bond payable to the City of Oshkosh **on the form provided by the City of Oshkosh** in an amount of not less than five percent (5%) of the total amount of the Bid as a guarantee that if the Bid is accepted, Bidder will execute and file proper Contract and Bond within ten (10) days after the award of the Contract. The Bid Bond can be presented in pdf format. If the successful bidder executes the Contract and files the necessary bonds within the allowed time, then the Bid Bond shall be released. If the successful bidder fails to execute the Contract and file the Contract Bond within the allowed time, then the Bid Bond shall be forfeited to the CITY as liquidated damages.

No bids will be withdrawn for a period of sixty (60) days after the scheduled time of opening bids.

The CITY reserves the right to reject any and all bids and to waive any informalities.
